THAT ON the 25th day of JUNE, 1969, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of uranium and other valuable minerals, within the limits of this claim as hereinafter established.

THAT THE NAME of this claim is JOHN # 39

THAT THE LOCATOR..... of this claim (is) ~~is~~ the undersigned, each owning an equal undivided share thereof, or the proportion after his name shown.
