THAT THE LOCATOR of this claim (is) the undersigned,

THAT THE EXTENT of this claim is as follows: From the point at which a copy of this Certificate is posted, the point of discovery, thence, in length, 1490 feet in a EAST direction and 10 feet in a WEST direction and in width, 150 feet in a NORTH direction and 150 feet in a SOUTH direction, comprising in all 1500 feet in length and 300 feet in width.
