THAT ON the 24th day of SEPTEMBER, 1969, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of URANIUM

and other valuable minerals, within the limits of this claim as hereinafter established.

THAT THE NAME of this claim is Cow No. 13

THAT THE LOCATOR of this claim (is) the undersigned,

THAT THE EXTENT of this claim is as follows: From the point at which a copy of this Certificate is posted, the point of discovery, thence, in length, 1490 feet in a WEST direction and 1.0 feet in a EAST direction and in width, 300 feet in a NORTH direction and 300 feet in a SOUTH direction, comprising in all 1500 feet in length and 600 feet in width.
