THAT THE EXTENT of this claim is as follows. From the point at
which a copy of this Certificate is posted, the point of discovery,
thence, in width 300 ft. in a N direction and 300 feet in a
S direction, and in length 300 feet in a West direction and
1200 feet in a East direction, comprising in all 1500 feet in
length and 600 feet in width.
