

## NOTICE AND CERTIFICATE OF LOCATION--LODE

THAT ON the 3 day of Oct, 1969, which date is hereby  
established as the date of discovery, the undersigned discovered a  
lode, ledge, vein or deposit of valuable minerals, consisting of  
uranium and other minerals, and other valuable minerals, within the limits  
of this claim as hereinafter established.

THAT THE NAME of this claim is F.L.- 3641  
THAT THE LOCATOR of this claim is the undersigned, each owning an  
equal undivided share thereof, or the proportion after his name shown.

THAT THE EXTENT of this claim is as follows. From the point at  
which a copy of this Certificate is posted, the point of discovery,  
thence, in width 300 ft. in a NE direction and 300 feet in a  
SW direction, and in length 30 feet in a NW direction and  
1470 feet in a SE direction, comprising in all 1500 feet in  
length and 600 feet in width.

THAT THE EXTERIOR boundaries of this location are distinctly
