

NOTICE AND CERTIFICATE OF LOCATION--LODE

who is a Citizen of the United States of America, by legal organization,
hereby claim(s) the land hereinafter described as a Lode
Mining Claim, under and pursuant to the Laws of the United States
of America and of the State of Wyoming, and, in making such claim
and for the purpose of establishing its right thereto, hereby certi-
fies,

THAT ON the 30 day of Sept, 1969, which date is hereby
established as the date of discovery, the undersigned discovered a
lode, ledge, vein or deposit of valuable minerals, consisting of
uranium and other minerals, and other valuable minerals, within the limits
of this claim as hereinafter established.

THAT THE NAME of this claim is F.L.- 3650

THAT THE LOCATOR of this claim is the undersigned, each owning an
equal undivided share thereof, or the proportion after his name shown.

THAT THE EXTENT of this claim is as follows. From the point at
which a copy of this Certificate is posted, the point of discovery,
thence, in width 300 ft. in a NE direction and 300 feet in a
SW direction, and in length 20 feet in a SE direction and
180 feet in a W direction, comprising in all 1500 feet in
length and 600 feet in width.

THAT THE EXTERIOR boundaries of this location are distinctly
marked by posts or monuments at each corner and its boundaries can be
readily traced, viz.


