THAT THE EXTENT of this claim is as follows. From the point at
which a copy of this Certificate is posted, the point of discovery,
thence, in width 300 ft. in a NW direction and 300 feet in a
SE direction, and in length 30 feet in a NE direction and
1470 feet in a SW direction, comprising in all 1500 feet in
length and 600 feet in width.
