THAT THE LOCATOR of this claim is the undersigned, each owning an
 equal undivided share thereof, or the proportion after his name shown.

THAT THE EXTENT of this claim is as follows. From the point at
 which a copy of this Certificate is posted, the point of discovery,
 thence, in width 300 ft. in a NW direction and 300 feet in a
SE direction, and in length 20 feet in a SW direction and
1480 feet in a NE direction, comprising in all 1500 feet in
 length and 600 feet in width.


