THAT ON the 16th day of OCTOBER, 1969, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of URANIUM

and other valuable minerals, within the limits of this claim as hereinafter established.

THAT THE LOCATOR of this claim is the undersigned,
