THAT THE EXTENT of this claim is as follows: From the point at which a copy of this Certificate is posted, the point of discovery, thence, in length, 1190 feet in a NORTH direction and 10 feet in a SOUTH direction and in width, 300 feet in a WEST direction and 300 feet in a WEST direction, comprising in all 1200 feet in length and 600 feet in width.
