THAT ON the 15th day of October, 1969 which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of URANIUM and other valuable minerals, within the limits of this claim as hereinafter established.

THAT THE NAME of this claim is Bull No. 147

THAT THE LOCATOR of this claim (is) the undersigned,

THAT THE EXTENT of this claim is as follows: From the point at which a copy of this Certificate is posted, the point of discovery, thence, in length, 1490 feet in a EAST direction and 10 feet in a WEST direction and in width, 300 feet in a NORTH direction and 300 feet in a SOUTH direction, comprising in all 1500 feet in length and 600 feet in width.

THAT THE EXTERIOR boundaries of this location are distinctly marked by posts or monuments at each corner and its boundaries can be readily traced, viz:
