THAT ON the 3rd day of NOVEMBER 1969, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of URANIUM and other valuable minerals, within the limits of this claim as hereinafter established.

THAT THE NAME of this claim is DEER No. 15THAT THE LOCATOR of this claim is the undersigned,
