THAT ON the 16th day of OCTOBER, 1969, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of URANIUM and other valuable minerals, within the limits of this claim as hereinafter established.
