Thence 600 feet in a northerly direction to the northwest corner,

Thence 1500 feet in an easterly direction to the northeast corner, the point of beginning.


The discovery monument lies midway between the two sides and is 10 feet from the WEST end and 1490 feet from the EAST end of this claim.

This claim is located in SW 1/4 Section 17 Township 31 North, Range 109 West, 6th p.m., Sublette County, Wyoming.

To TIE this claim to the Public Survey, begin at the NW corner, Section 32 Township 31 North, Range 109 West, bear 12,000' NORTH and 1500' EAST to the northeast corner of this claim.


