We, the undersigned, James L. Hill, party of the first part, and George E. Parody, party of the second part, make agreement to the following lease. The party of the first part leaves to the party of the second part the following described land, as follows:

$\frac{1}{2}$  NE $\frac{1}{4}$  Sec. 21 and  $\frac{1}{4}$  NW $\frac{1}{4}$  Sec. 22, Township 38 N. Range 113 W. 6th P. Meridian. In Sublette County, Wyoming, for the term of (7) seven years.

The party of the second part agrees to the following terms. Fencing to be a three barb wire, posts one rod apart, and two stays between posts, and to be kept up in good condition at all times. And all lands under irrigation ditch to be put under cultivation by seeding same with tame hay, and grubbing sage brush off. Also to complete ditch, and to be kept in good condition.

All taxes to be paid when due.

The hay must not be sold or moved from stacks until taxes are paid in full.

The party of the first part reserves the right to dispose by sale of the above described land as follows; Should the above described land be sold within (5) five years, the party of the second part shall be renumerated for the work he has done, and it shall be appraised by three disinterested persons, selected by the parties of the lease.

Should the party of the second part fail to do the work agreed upon in seven years he shall pay for the work undone immediately after the expiration of lease.
