ARTICLES OF INCORPORATION OF THE PINEDALE
LIVE STOCK COMPANY.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned citizens of the United States, over the age of twenty-one years, and desiring to aid in the productive and industrial interests of the country, do, by these presents, voluntarily associate ourselves together for the purpose of forming a corporation, under and by virtue of the laws of the State of Wyoming, and we do hereby make, execute, and acknowledge in triplicate, this certificate in writing, and we do certify as follows:

ARTICLE I.

The Corporate name and style of said Corporation is, and shall be, the
PINEDALE LIVE STOCK COMPANY.

ARTICLE II.

The object for which the said Corporation is formed is to carry on, in all its branches, a general live stock and stock raising farm and range business; to buy, sell, breed, raise, export, import and generally deal in sheep, cattle, horses and all kinds of domestic animals. To buy, lease, or otherwise acquire, maintain and run registered cattle for market, and to construct and operate dipping vats, shearing pens, corrals, stock yards, warehouses, and any and all improvements necessary to the successful management of the live stock business; to carry on the business of wholesale and retail dealers in meat and meat products; and to operate in connection therewith, slaughter houses, stock yards, and live stock farms and ranches; also to operate and maintain cold storage warehouses, plants, and all buildings necessary or expedient for carrying on said business; to buy, lease or otherwise acquire farm lands and grazing lands necessary in the operation of sheep and live stock business; and to do generally any and all things necessary to the successful management of a live stock enterprise.

ARTICLE III.

The Capital Stock of the said Corporation shall be Fifty Thousand Dollars (\$50,000.), to be divided into Five Hundred (500) Shares of the par value of One Hundred Dollars (\$100.00) each, said Stock to be non-assessable.

ARTICLE IV.

The term of existence of said Corporation shall be fifty (50) years from and after the filing of this certificate of incorporation in the office of the Secretary of State in the City of Cheyenne, State of Wyoming.

ARTICLE V.

The affairs and management of said Corporation shall be under the control of three (3) Directors, and C. R. Ferris and Faye D. Ferris, of the City of Rawlins, County of Carbon, State of Wyoming, and J. T. Rutledge, of the Town of Pinedale, County of Sublette, State of Wyoming, are hereby selected and appointed to act as such Directors, and to manage the affairs of the said Company for the first year of its existence and until their successors have been elected and qualified according to law and the by-laws of said Company.

ARTICLE VI.

The office and principal place of business of said Corporation shall be in the Town of Pinedale, County of Sublette, State of Wyoming, and the operations of said Company shall be principally carried on in the County of Sublette, and elsewhere in the State of Wyoming; and in the discretion of the Board of Directors, a part of the
