IN THE MATTER OF THE PETITION OF LAWRENCE H. ECKLUND ASKING FOR THE ELIMINATION OF LANDS IN SECTION 31, T. 33 N.R. 108 W. FROM CERTIFICATE OF APPROPRIATION APPEARING OF RECORD IN CERTIFICATE RECORD 6, PAGE 101, SAME BEING ISSUED UNDER THE TERMS OF PERMIT NO. 626 ENL. OF THE PINE CREEK CANAL CO. NO. 1 CANAL DIVERTING WATER FROM PINE CREEK, IN WATER DIVISION NO. IV.

FINDINGS AND ORDER.

This matter coming regularly before the Board of Control this 24th day of November, 1923, the Board FINDS;

That the petitioner, Lawrence H. Ecklund, has shown by documentary evidence that he is the owner by warranty deed, of Lots 1, 2, 3, W₁ SE₁, NE₁ SW₁, E₁ NW₁ Sec. 31, T. 33 N. R. 108 W.;

That such lands have heretofore been irrigated through the Pine Creek Canal Co. No. 1 Canal under the terms of Permit No. 626 Enl., and further described in Certificate Record 6, Page 101;

That the petitioner has filed in the office of the State Engineer an application for the irrigation of 3.2 A. SW₁ NW₁, 12 A. SE₁ NW₁, 40 A. NE₁ SW₁, 37.9 A. NW₁ SW₁, 39 A. NW₁ SE₁, 38 A. SW₁ SE₁ of Sec. 31, T. 33 N.R. 108 W., through an enlargement of the Ecklund Ditch diverting water from the West Fork of New Fork River;

That the petitioner requests that the board eliminate from the said certificates of Appropriation, Certificate Record 6, Page 101, such lands described therein as are in conflict with his application for the enlargement of the Ecklund Ditch under temporary filing number 112/367.

The Board now being fully advised, ORDERS;

That the petition be granted;

That 73 A. W₁ SE₁, 40 A. NE₁ SW₁, 37.9 A. NW₁ SW₁, (Lot 3), 3.2 A. SW₁ NW₁ (Lot 2), 12 A. SE₁ NW₁ of Sec. 31, T. 33 N.R. 108 W. be eliminated from Certificate Record 6, Page 101.
