

And it further satisfactorily appearing to the Court that at the time of the death of said deceased the following named persons were the lawful heirs of said deceased, and entitled by the laws of the state of Wyoming to inherit said real estate hereinafter particularly, to-wit: Rose Wilson, widow of deceased, Frankie Drais Wilson, China Spears, Muriel Hudson and George T. Wilson, and that said named persons are all the heirs at law of said Abel Wilson.

It is therefore ordered, adjudged and decreed by this Court that the above named persons were and are the lawful heirs of said Abel Wilson, deceased, and entitled by the laws of the state of Wyoming to inherit his said real estate, and that there are no other heirs or said Deceased entitled under the laws of this State to share in the distribution of said estate, and that said Rose Wilson, widow of deceased, Frankie Drais Wilson, China Spears, Muriel Hudson and George T. Wilson, children of said decedent, are the sole heirs and next of kin of said deceased.

And it further satisfactorily appearing to the Court that the above named heirs did by Warranty Deed dated the 26th day of October 1923, and which deed was filed for record in the office of the County Clerk and Ex-Officio Register of Deeds in and for Sublette County, Wyoming, on the 14th day of January, 1924, at 9:00 o'clock A. M. and recorded in Book 1 of Deeds on Page 54, grant, bargain, sell and convey the real estate of said estate hereinafter particularly described, to The First National Bank of Kemmerer, Kemmerer, Lincoln County, Wyoming. And it further appearing to the Court that there is no question or dispute as to or concerning the conveyance of said real estate as aforesaid or the distribution thereof, and no person or corporation other than the said The First National Bank of Kemmerer is here claiming any interest in and to said real estate, or any title or equity therein, or objecting to the distribution of said real estate in accordance with the prayer of the petition for distribution herein, and said The First National Bank of Kemmerer appearing and claiming said real estate and asking that the same be decreed to it by virtue of said Warranty Deed:

It is therefore Ordered, adjudged and decreed, and this does order, adjudge and decree that the residue of said estate hereinafter particularly described be and the same is hereby distributed as follows, to-wit:-

The whole of said residue to The First National Bank of Kemmerer, Kemmerer, Lincoln County, Wyoming.

The following is a particular description of the said residue of said estate referred to in this decree and of which distribution is now ordered, as aforesaid, to-wit:

The southeast quarter of the northwest quarter (SE $\frac{1}{4}$ NW $\frac{1}{4}$), the northwest quarter of the southeast quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$), the south-half of the southeast quarter (S $\frac{1}{2}$ SE $\frac{1}{4}$), the east-half of the southwest quarter (E $\frac{1}{2}$ SW $\frac{1}{4}$) of Section three (3); the north-half of the northeast quarter (N $\frac{1}{2}$ NE $\frac{1}{4}$) of Section ten (10); the southwest quarter of the northeast quarter (SW $\frac{1}{4}$ NE $\frac{1}{4}$), and the southeast quarter (SE $\frac{1}{4}$) of Section eleven (11); the southwest quarter of the southwest quarter (SW $\frac{1}{4}$ SW $\frac{1}{4}$) of Section twelve (12) and the North-half of the northwest quarter (N $\frac{1}{2}$ NW $\frac{1}{4}$) of Section thirteen (13), all in Township thirty-three (33) North, Range 113 West of the Sixth Principal Meridian.

Together with all water and water rights thereunto belonging or in anywise appertaining.
