AND ALSO

Any and all gas wells, oil wells, or other wells, and and all oil derricks, oil tanks, oil or gas pipe lines, or water pipe lines, including the rights of way therefor, and any and all machinery, equipment, materials and supplies whatsoever and any and all buildings, improvements and appurtenances situate upon, belonging to or in any way whatsoever appertaining to the premises above described;

for certain materials, supplies and machinery furnished, sold and delivered to the said WYOTAH OIL AND GAS COMPANY by the said THE CONTINENTAL SUPPLY COMPANY under and by virtue of a certain oral contract, hereinafter set forth, said materials, supplies and machinery being so furnished under said contract for constructing, altering, digging, drilling, boring, operating or repairing gas wells, oil wells, or other wells, or for altering, repairing or constructing oil derricks, oil tanks or oil or gas pipe lines, or other improvements, upon said above described premises, and upon which said materials, supplies and machinery there is now due and owing and there has been due, owing and unpaid for a period of more than ten (10) days last preceding the date of these presents a sum exceeding Ten (\$10.00) Dollars, as hereinafter more completely set forth.

That the said THE CONTINENTAL SUPPLY COMPANY agreed to furnish, sell and deliver to the said WYOTAH OIL AND GAS COMPANY the certain supplies, materials and machinery hereinafter set forth, for the purposes aforesaid, and that in consideration therefor the said WYOTAH OIL AND GAS COMPANY agreed to pay cash therefor as soon as said materials, supplies, and machinery were delivered to the said WYOTAH OIL AND GAS COMPANY.
