NOTICE IS HEREBY GIVEN; that Sherman Shinsel of LaBarge in the County of Lincoln in the State of Wyoming at a time hereinafter mentioned performed work and labor upon one Star No 28 Oil Drilling Machine and the said rig was at that time engaged in drilling a certain oil well, and upon the derrick, engine, boiler, cables, bits, casing and all tools used in drilling that certain oil well known as the Wm. Kahl Oil and Gas Permit Well in the LaBarge Oil Field now upon that certain piece or parcel of land situated in the County of Sublette in the State of Wyoming being in Section 35, Township 27, N. Range 113 W. 6th P.M. in Wyoming and more particularly described as that portion thereof upon which said derrick is now situated and where drilling operations upon the said well of the said Wm. Kahl Permit for Oil and Gas have heretofore been carried on. All of the above mentioned property is sought to be charged with this lien, which same includes the casing, and title to the hole or well above mentioned and upon said ground.

That one W. Miltz entered into a contract with Wm. Kahl for the purpose of drilling an Oil well upon the - - - - and the said W. Miltz employed the said Sherman Shinsel to do work upon the said derrick, engine, boiler, cables bits and casings &c in connection with the drilling of the said Oil Well for the production of Oil and Gas. for the stipulated and agreed sum of Eight dollars a day for each and every day's work thereon by the said Sherman Shinsel and that the same would be paid promptly upon the said work being done by the said Sherman Shinsel.
