THIS AGREEMENT made and entered into this 7th day of May A.D. 1926, by and between Garland P. Fallis of Los Angeles, California, party of the first part, and I. E. Willey of Salt Lake City, Utah, party of the second part, Witnesseth:

WHEREAS on the 6th day of May A.D. 1926 a drilling contract was entered into between the first party and the permittee named in Permit Serial Number 07671, covering all of Section 8, Township 27 North, Range 113 West, Sublette County, Wyoming, and it is the intention of said first party to drill upon said land in accordance with the terms of said contract and the terms of said permit and the rules and regulations of the Department of the Interior, and will, when oil in commercial quantities has been discovered thereupon, be entitled to a lease from the United States Government, and in connection with the permittee will be entitled to select a portion of said permitted area as preference ground and subject to five percent (5%) royalty to the Government; and

WHEREAS said second party was instrumental in consummating the arrangements and perfecting a drilling contract with said first party and is therefore entitled to compensation for services earned in that connection; and

WHEREAS the said first party is willing to allow said second party certain interest in a portion of the lands embraced within said permitted area to be selected in the manner hereinafter set forth; and

WHEREAS said second party is willing to accept said interest as compensation and consideration for the services performed in connection with said drilling contract:

NOW, THEREFORE, in consideration of the services thus performed by the said second party and the mutual promises and agreements, and the sum of One Dollar (\$1.00) paid by the second party to the first party, the receipt whereof is acknowledged by the said
