KNOW ALL MEN BY THESE PRESENTS:-

WHEREAS, under Section 13 of the Act of February 25, 1920 (41 Stat. 437), Marion W. Bird heretofore filed in the local land office at Evanston, Wyoming, her application Serial No. 010270, for a permit to prospect for oil and gas the following described lands in Sublette County, Wyoming, to-wit:

All of Section 21; N $\frac{1}{4}$ NE $\frac{1}{4}$ , SE $\frac{1}{4}$ NE $\frac{1}{4}$  and E $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 28; and the NE $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 33, all in Township 27 North, Range 113 West, 6th P. M.

AND WHEREAS, J. H. Garrett, Marlow L. Cummings, E. L. Chesney and L. B. McCornick each claimed an interest in said application No. 010270, adverse to said Marion W. Bird; and

WHEREAS, in full settlement and satisfaction of all claims and demands of said Garrett, Cummings, Chesney and McCornick, a compromise agreement was entered into between said last named parties, Marion W. Bird, and the Utah Oil Refining Company on the 28th day of May A. D. 1926, and pursuant to the terms of said agreement said Marion W. Bird did on the 28th day of May A. D. 1926, grant, sell, assign, transfer and convey and set over unto said J. H. Garrett, Marlow L. Cummings, E. L. Chesney and L. B. McCornick each the following described royalties and interests in and under said oil and gas prospecting application, Serial No. 010270, to-wit:

(A) A royalty of two per cent (2%) of the value of all oil and/or gas produced, saved and marketed from the lands embraced in any permit which may be issued to the party of the first part pursuant to her said application, which may hereafter be included in any lease or leases issued by the United States of America to the party of the first part, under which the royalty reserved to the United States shall not exceed five per cent (5%);

(b) A royalty of fifty-four one-hundredths of one per cent (0.54 of 1%) of the
