TO ALL TO WHOM THESE PRESENTS MAY CONCERN: Know ye, that Willis N. Bartlett a citizen of the United States, of Kendall, County of Sublette, State of Wyo., do hereby declare and publish as a legal notice to all the world, that I have a valid right to the occupancy, possession and enjoyment of the Sno Ball Tunnel, located January 14, A. D. 1921, for the discovery of mines and the development of lodes, and situate in Un Organized Twin Creek Mining District, Sublet County, State of Wyo. described as follows, to-wit:

Mouth of tunnel situate about 730 ft North 24° West from Section corner no 26

T. 38. N. R. 111 W; from the mouth of the tunnel The Center line runs North 2°

West 3000 ft to the end Stake (The tunnel goes a little crooked on account of bad ground

Size of tunnel 3 ft 6 in's wide by 6 ft feet high in the clear.

Course of tunnel from its mouth, North By 2° West 3,000 feet to the North end of said tunnel, at which end is set a substantial Post being the end Of said Sno Ball Tunnel and between the tunnel mouth and the end - - the center line of the tunnel is marked at 150 feet, 380 feet, 580 feet, 1180 feet, 1570 feet, 1925 feet, 2500 feet, from the mouth by marked stakes or blazed and marked trees. From the end Post the line bears E 2° North 1500 ft to the N.E corner Stake bears West 2° South 1500 ft to the NW corner Stake from said end E 2° N, 1500 ft set a stake @ the Slide rock at foot of a cliff from said end W 2° S, set a stake 1500 ft in the open cuntry from mouth of tunnel, set a stake E. 2° North 1500 ft on open hill side surrounded by timber from mouth of tunnel, set a stake West 2° South 1500 ft in open ground close to timber which last four mentioned stakes Mark the exterior corners of the claim of said tunnel site.

And I claim for line of tunnel 1,500 feet on each side of the center of the bore or course of the tunnel, and the right to all lodes which may be discovered in the due prosecution of said tunnel within 1,500 feet on each side of the center of said line.

I also claim a square tract of land 125 feet on each side of the mouth of tunnel and extending 250 feet immediately below the mouth of the tunnel, as staked upon the ground, for dumping purposes.

Together with all and singular there hereditaments and appurtenances thereunto belonging or in anywise appertaining, and all rights granted to the locator as tunnel rights under the terms of Section 2323 of the Revised Statutes of the United States.
