

let, lease, and demise certain real estate of said deceased; and, having proved to the satisfaction of the Court that the order herein made requiring all persons interested to show cause why said real estate should not be leased has been published for three successive weeks as required by law, in the Pinedale Roundup, a newspaper of general circulation printed and published in Sublette County, State of Wyoming; and the hearing having been postponed to this time; and no persons having appeared and filed objections to the granting of said petition, the Court thereupon proceeds to the hearing of said petition, and after hearing the evidence, the Court, being satisfied that the same is for the advantage of the estate, grants said petition,

IT IS THEREFORE ORDERED by the Court, That Arthur W. West, as Administrator of the Estate of Samuel F. Stundevant, Deceased, be authorized, empowered, and directed to make a lease of the land herein described, for a period of not less than two years, nor more than five years, at a rental of not less than One Hundred Twenty five & no/100 (\$125.00) Dollars per year, and upon the terms and conditions following, to-wit; said lease to be non-transferable, and the lessee, during the term of said lease, is to reconstruct certain fences on the original homestead of the decedent by tearing down and rebuilding the same with new posts, for which he may deduct the sum of forty cents per ten foot panel from the rental, and to construct new fence around the additional 420 acres of the estate, for which he may deduct the sum of twenty cents per ten foot four wire panel and the cost of the wire from said rental for the year or years such re-construction or construction is done.

Said real estate is described as follows, to-wit; The East half of the Northeast Quarter (E $\frac{1}{4}$ NE $\frac{1}{4}$), Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) and North half (N $\frac{1}{2}$) of Section 14, Township 37, Range 110 West of the 6th P. M., the Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ NE $\frac{1}{4}$), South half of the Northwest Quarter (S $\frac{1}{2}$ NW $\frac{1}{4}$), North half of the Southwest Quarter (N $\frac{1}{2}$ SW $\frac{1}{4}$) the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 14, Township 37, Range 110 West of the 6th P. M., and the West half of the Southeast Quarter (W $\frac{1}{2}$ SE $\frac{1}{4}$) of Section 11, Township 37, Range 110 West of the 6th P. M.
