WHEREAS on or about the 18th day of July A. D. 1923, pursuant to an Application therefore, a permit Serial No. 07674 U. S. Land Office, Evanston, Wyoming, granting the exclusive right to prospect for oil and gas, was issued to the LaBarge Oil Company a Wyoming corporation, on the following described land:

The West Half (W $\frac{1}{2}$ ) of Section 34, Township 27 North, Range 113 West, 6th Principal

Meridian, Wyoming, consisting of approximately 320 acres.

WHEREAS on the 4th day of February A. D. 1924 by the terms of an operating agreement duly and regularly executed and delivered, said LaBarge Oil Company granted to Ivan S.
