THIS AGREEMENT, made and entered into this first day of OCTOBER, 1925, by and between Myrta Bonnett and Mrs. Dorothy M. Fearn, hereinafter called "The Owner", the party of the first part, and Thomas Marioneaux and J. Tracey Wootton, of Salt Lake City, Utah, hereinafter called "The Contractor", the parties of the second part,  
W I T N E S S E T H:-

That, Whereas, under Section 13 of the Act of Congress of February 25, 1920, there was issued to Myrta Bonnett, through the local Land Office at Salt Lake City, Utah, upon her application, Serial No. 09589, a permit to prospect for oil and gas, upon land, which, among other lands includes the tract described as follows:-

The South Half of Section 2; the North Half of the Northwest quarter, and the South Half of the Northeast quarter of Section 26, in Township 27 North, Range 113 West of the 6th principal meridian, of an area of approximately 480 acres;  
and

WHEREAS, a one-half interest in said permit has been assigned to Mrs. Dorothy M. Fearn, above mentioned, which said assignment has been consented to by the Department of the Interior, and,

WHEREAS, the parties hereto believe the lands described in said permit contain valuable deposits of oil and gas, and

WHEREAS, the Owner desires to contract for the exploitation, development and operation of said lands, and the production of the oil and gas therein, in full compliance with said Act of Congress and the regulations thereunder, and,

WHEREAS, the Contractor is able, efficiently and economically to prospect for oil and gas on said premises, and to exploit, develop, produce and handle any oil or gas that may be found in economical quantities therein, and to furnish the necessary working
