WHEREAS under date of February 4th, 1924, Kemmerer La Barge Oil Company, a corporation, entered into an operating agreement with Ivan S. Jones (recorded in Book 1, of Miscellaneous on Page 286 of the records of the County Clerk of Sublette County, Wyoming) pertaining to the development and operation for oil and gas on the following described lands situate in Sublette County, Wyoming to-wit:

East Half (E½) of Section 34, Township 27 North, Range 113 West 6th Principal Meridian, Wyoming.

which lands are covered by an oil and gas prospecting permit issued by the United States bearing Serial Number 07675 and

WHEREAS said contract under date of February 11, 1924, was by said Ivan S. Jones duly assigned to the Wyotah Oil and Gas Company, a corporation of Wyoming and

WHEREAS thereafter and on the 23rd day of April 1924 the said Wyotah Oil and Gas Company duly assigned all of its right, title and interest in and to said contract and said lands to Lester S. Scoville, of Ogden, Utah and on the 12th day of August 1926 said Lester S. Scoville duly assigned all of his right, title and interest in said contract and assignments to the Beneficial Oil Company, a corporation.

NOW THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and of the rights and benefits, and in pursuance of a contract dated September 8th 1926, by and between the California Petroleum Corporation, a Utah corporation, hereinafter called "Contractor" of the one part, and Beneficial Oil Company, a corporation of Utah herein called "Owner" of the other part, said Owner hereby assigns transfers and sets over unto said Contractor, its successors and assigns the above described drilling contract and all of its right, title and interest in and under same and in and to the above described lands.

Said Owner, for itself, successors and assigns, hereby warrants and covenants to and with said Contractor, its successors and assigns, that it is the present Owner of said Drilling Contract and of the right, title and interest given and granted thereby; that the same is valid and in full force and effect; that no default in the performance of said agreement for which any forfeiture may or might now be declared or enforced has been committed or suffered by it or its predecessors in interest; that said Owner is now in lawful possession of above described lands under said Contract and assignments; that it has the lawful right, and full authority, to make, execute and deliver this assignment; that the estate arising under said contract is subject to no liens, assessments, prior sales, taxes or incumbrances of any kind or character, other than in said Contract and Assignments stated, except an overriding royalty of two and one half per cent (2½%) of the production of oil produced and saved and gas produced and sold from said land in favor of Wyotah Oil and Gas Company; and title in said Owner to said Contract and the Assignments, said Owner its successors and assigns will warrant and forever defend.
