Fuller, the duly elected, qualified and acting County Clerk and Ex-Officio Clerk of the District Court of Sublette County, Wyoming, do hereby certify that on April 10, 1924, a suit was filed in said Court entitled "STATE BANK OF PINEDALE, A Corporation, Plaintiff vs. GEORGE R. DeNISE, Defendant," being numbered 19, said suit being an action on a promissory note in the sum of \$1330 together with interest, costs and attorney's fees.
