

the said party of the first part, his heirs, executors, administrators, agent, attorney, or assigns at their election to declare the said term ended, and into the said premises, or any part thereof, either with or without process of law to re-enter, and the said party of the second part, or any other parties or party occupying, in or upon the same, to expel, remove, and put out, using such force as may be necessary in so doing, and the same premises to again repossess and enjoy, as in their first and former state. And if at any time said term shall be ended at such election of said party of the first part, his heirs, executors, administrators and assigns, as aforesaid, or in any other way, the said party of the second part, his executors and administrators, do hereby covenant and agree to surrender and deliver up said above described premises and property peaceably to the said party of the first part, his heirs, executors, administrators and assigns, immediately upon the termination of said term as aforesaid, and if he shall remain in possession of the same ten days after notice of such default, or after the termination of this lease, in any of the ways above named he shall be guilty of forcible detainer of said premises under the statute, and shall be subject to all the conditions and provisions above named, and to eviction and removal, forcible or otherwise, with or without process of law, as above stated.
