

WHEREAS, one Lionel H. Gray has filed and secured an OIL AND GAS prospecting permit from the United States of America through the United States Land Office at Evanston, Wyoming, Serial No. 07698 in the Piney-LaBarge Oil Field, covering lands more particularly described as follows:

WHEREAS, the said Lionel H. Gray did heretofore and on the 4th day of September, 1923, sell, assign and transfer unto R. C. Horn of Salt Lake City, Utah, the above described prospecting permit and which transfer and assignment stipulated and stated that the said Lionel H. Gray should receive a TWO PER CENT. (2%) OVER-RIDING ROYALTY over and above the Government Royalty thereon under said permit or any renewal thereof.

WHEREAS, the said Lionel H. Gray did heretofore and on the 23rd day of March, 1926, sell, assign and transfer unto the said R. C. Horn a ONE-HALF OF ONE PER CENT (1/2 of 1%) OVER-RIDING ROYALTY under said above prospecting permit.

WHEREAS, the said R. C. Horn did heretofore and on the 31st day of December, 1926, sell, assign, and transfer unto the said James E. Griffith the said ONE-HALF OF ONE PER CENT. (1/2 of 1%) OVER-RIDING ROYALTY under said above prospecting permit.

All of the above with the exceptions of the last two assignments mentioned, namely that of the said Lionel H. Gray to the said R. C. Horn, and that of the said R. C. Horn unto the said James E. Griffith, are a matter of record in the United States Land Office, Evanston, Wyoming.

NOW, THEREFORE, for and in consideration of ONE DOLLAR and other good and valuable consideration, receipt of which is hereby acknowledged, the said James E. Griffith does hereby bargain, sell, set-over, and transfer unto the said Ernest D. Somners an undivided over-riding royalty of ONE-EIGHTH OF ONE PER CENT. (1/8 of 1%) over and above the Government royalty in and to all of the oil and gas produced in the lands covered by said permit more particularly described above.

TO HAVE AND TO HOLD the above described over-riding royalty assigned and conveyed with the rights, privileges, and claims aforesaid unto the said Ernest D. Somners, his heirs and assigns forever.
