That I, A. J. BANDY, of Los Angeles, California, for a consideration of ONE DOLLAR to me paid by THE HOVEY-BANDY CORPORATION of Los Angeles, California, the receipt whereof is hereby confessed, together with other good and valuable considerations, do hereby sell, assign, transfer and set over unto said THE HOVEY-BANDY CORPORATION, its successors and assigns forever all my right, title and interest of, in and to that certain agreement in writing dated May 18, 1926, executed by the CRETACHOUS OIL COMPANY, first party, MID-MOUNTAIN OIL COMPANY, second party, CHAS.
