THIS AGREEMENT, Concluded this 26th day of May, A. D. 1926, between W. S. Kimball, Sr. and A. H. Ziehlsdorff, first parties and Elmer Manske and A. G. Burritt, second parties,

WITNESSETH:

Under date of January 19th, 1926 Elizabeth Chapel as lessor, executed and delivered to first parties as lessee, oil and gas lease covering

Lots 9 and 11 and the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 24; Lots 2 and 3, the Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$ NW $\frac{1}{4}$) and the East Half of the Northwest Quarter (E $\frac{1}{2}$ NW $\frac{1}{4}$) of Section 25, Lots 1 and 7 of Section 26, all in Township 28 North, Range 112 West of the Sixth Principal Meridian, Wyoming

reference being made to said oil and gas lease as fully as if same were expressly incorporated herein.

For values received by first parties from second parties, receipt of which is acknowledged, first parties covenant that following commercial discovery on said premises, first parties shall thereafter pay second parties, in equal shares thereof, the posted field market value of two and one-half (2 $\frac{1}{2}$) per cent of all oil and gas produced, saved and marketed from said premises under said lease by first parties, their legal representatives or assigns, royalty payments to be made on the twentieth (20th) day of each calendar month covering production marketed the previous calendar month, and to be accompanied by production statements, payments to be made in depositories designated in writing by second parties.

The within agreement shall run to and bind the heirs, legal representatives and assigns of the parties hereto.

In said lease by typographical error the name of A. H. Ziehlsdorff incorrectly appears as "A. H. Ziehlsdroff".
