THIS AGREEMENT, Concluded this 26th day of May, A. D. 1926, between W. S. Kimball, Sr. and A. H. Ziehlsdorff, first parties and Elmer Manske and A. G. Burritt, second parties,

WITNESSETH:

Under date of January 6th, 1926 Jones Lindley as lessor, executed and delivered to first parties as lessee, oil and gas lease covering

Lots 9 and 12, the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 13 and Lots 2 and 3 of Section 24, Township 28 North, Range 112 West; Lots 5 and 8, Section 13, Township 28 North, Range 112 West; East Half of the Northwest Quarter (E $\frac{1}{2}$ NW $\frac{1}{4}$) and Lots 1 and 2 of Section 7, Township 28 North, Range 111 West; Lot 14 of Section 1, Lots 1, 6 7 of Section 12, Township 28 North, Range 112 West; Lots 15 and 16 of Section 1 and Lots 2 and 3 of Section 12, Township 28 North, Range 112 West; Lots 8, 9 and 10 and a part of the North half of Lot 13 (shown by a certain deed) of Section 12, Township 28 North, Range 112 West; 15.54 acres of lot 3 of Section 7, Township 28 North, Range 111 West and 11.06 acres part of Lot 14 in Section 12, Township 28 North, Range 112 West of the Sixth Principal Meridian, and the Northwest Quarter of the NE $\frac{1}{4}$ Sec. 7, Twp. 28N. Rg. 111 W.

reference being made to said oil and gas lease as fully as if same were expressly incorporated herein.

For value received by first parties from second parties, receipt of which is acknowledged, first parties covenant that following commercial discovery on said premises, first parties shall thereafter pay second parties, in equal shares thereof, the posted field market value of two and one-half (2 $\frac{1}{2}$ %) per cent of all oil and gas produced, saved and marketed from said premises under said lease by first parties, their legal representatives or assigns, royalty payments to be made on the twentieth (20th) day of each calendar month covering production marketed the previous calendar month, and to be accompanied by production statements, payments to be made in depositories designated in writing by second parties.

The within agreement shall run to and bind the heirs, legal representatives and assigns of the parties hereto.

In said lease/typographical error the name of A. H. Ziehlsdorff incorrectly appears as "A. H. Ziehlsdroff."
