AMENDMENT OF OIL AND GAS LEASE

D. 1926 which said oil and gas lease was filed for record at Pinedale in the county of Sublette, state of Wyoming, the 25th day of March 1926, at 9 o'clock A. M. and duly recorded in Book 1 of Mscs., Page 380 and whereas Charles P. Budd for the sum of \$1.00 paid him in hand by the said Guy B. Hockett, the receipt of which, is hereby acknowledged and for other good and valuable considerations, all of that part of the above said lease, set out in Paragraph numbered first, and which reads as follows:

FIRST: To deliver to the credit of the lessor on the grounds hereinabove described or in the pipe line to which the lessee may connect its wells (less transportation costs government charges and taxes) as rent or royalty, seventeen and one-half per cent (17½%) part of all oil and gas produced and saved from the leased premises,

is hereby amended to read as follows, to-wit:

FIRST: To deliver to the credit of the lessor on the grounds hereinabove described or in the pipe line to which the lessee may connect its wells (less transportation costs government charges and taxes) as rent or royalty, twelve and one-half per cent (12½%) part of all oil and gas produced and saved from the leased premises.
