

Mary Jo Poston, daughter of deceased, aged 7 years; Polly Lou Poston, daughter of deceased, aged 5 years; and Patricia Poston daughter of deceased, aged 2 years; all residing in the City of Rock Springs, State of Wyoming.

And the court further finds that since the rendition of the Final Account and Petition for Distribution, the sum of Four Thousand (\$4,000.00) Dollars has come into the hands of the administratrix, which was borrowed by her for the purpose of paying the current running expenses of the sheep outfit owned by said estate, and that the same amount has been expended in paying and liquidating said expenses; and that the estimated expenses, court costs, publication fees, recording fees and attorney's fees, of closing said estate, will amount to the sum of Five Hundred Thirty-seven and 60/100 (\$537.60) Dollars, and that there will remain in the possession of said administratrix lawful money of the United States, as cash on hand in the Rock Springs National Bank of Rock Springs, Wyoming, the sum of One Hundred Ninety-six and 05/100 (\$196.05) Dollars, together with the real and personal property heretofore specifically described, to be distributed to the heirs and next of kin heretofore named, in the following manner, to-wit:

And it is further ordered and decreed that the residue and remainder of said estate of Frank J. Poston, deceased, heretofore particularly described and now remaining in the hands and possession of said administratrix, be and the same is hereby distributed and decreed to the following named persons in fee, to-wit:

To Jean Poston Smith, formerly Jean Poston, widow of deceased, of Rock Springs, Wyoming, an undivided one-half interest in and to all of the real and personal property belonging to said estate, hereinafter more specifically described;

And to Franklin Poston, son of Deceased; Mary Jo Poston, daughter of deceased; Polly Lou Poston, daughter of deceased; and Patricia Poston, daughter of deceased; all minors residing at Rock Springs, Wyoming, by and through Jean Poston Smith, formerly Jean Poston, their duly appointed, qualified and acting guardian; an undivided one-half interest in and to all of the real and personal property belonging to said estate, hereinafter more specifically described, in equal shares:
