

land and drilling therewith commenced by the said 28th day of May, 1928, or in case the second party or his assignees fail to drill diligently thereafter until a depth of 2500 feet is reached, unless oil or gas in paying quantities is found at a lesser depth, the first party shall be entitled to repossession of said land and all rights of the second party under the said drilling contract shall be terminated.

However, a monetary contribution by the second party, satisfactory to the United States Government, to the well known as the "Corder" well, being drilled by Lester Scoville shall constitute a fulfillment of the requirements of this agreement in lieu of the conditions and requirements imposed by the above paragraph 4 of this agreement.

THIS IS TO CERTIFY, That at a regularly called meeting by the holders of Becklinger Syndicate, a common law trust company existing by virtue of an Agreement and Declaration of Trust dated May 9, 1927, and filed for record in the office of the County Clerk and Recorder of Lincoln County, Wyoming, in Book 3 of Mixed Records, at page 444 thereof, and in the office of the County Clerk and Recorder of Sublette County, Wyoming, in Book 2 of Miscellaneous Records, page 163, said meeting being held on the 23rd day of January, 1928, and a quorum being present, the following resolution was proposed, seconded, and adopted by a vote of more than two-thirds of the units in said Syndicate:

"BE IT RESOLVED,

"THAT, WHEREAS Section 5 of the Agreement and Declaration of Trust of the Becklinger Syndicate provides that the beneficial interest in said trust shall in the first instance be divided into one hundred ninety-two (192) units and that trustees shall cause certificates to be issued representing said units,

"AND, WHEREAS it is now desired to increase the number of units in said Syndicate and to have certificates issued,

"NOW, THEREFORE, it is hereby resolved:

"That the number of units of ownership in said Syndicate shall be, and the same is, hereby increased to a total of three hundred (300) units and the trustees are hereby authorized and directed to issue certificates for two hundred and twenty two (222) units and to hold as unissued units, for the benefit of said Syndicate and to be issued as the unit-holders may hereafter direct by vote of two-thirds or more of the units issued, a total of seventy-eight (78) units."
