Sanderberg, residing at Salt Lake City, Utah, in consideration of the sum of one (1) Dollar, and other valuable considerations, to me in hand paid, receipt of which is hereby acknowledged, do hereby sell, transfer and assign to Mary J. Farnsworth of Salt Lake City, Utah, her heirs, executors, administrators, successors and assigns, an undivided one-fourth interest in and to that certain application for oil and gas prospecting permit #010122, filed in the Evanston Land Office by Nellie M. Sanderberg, of Salt Lake City, Utah, and the permit issued thereon covering the following described lands, to-wit:
