## ORDER OF APPOINTING ADMINISTRATOR

The Petition of John F. Wilhelm praying for Letters of Administration of the Estate of Rosa L. Wilhelm, deceased, coming on regularly to be heard, and due proof having been made to the satisfaction of the Judge of said Court that notice in all respects according to law has been given, and all and singular the law and the evidence understood and fully considered; whereupon it is here adjudged and decreed that the said Rosa L. Wilhelm died on the 12th day of August, 1918 intestate, in the said County of Lincoln, that she was a resident of said Lincoln County, Wyoming, at the time of her death; and that she left Estate in the said County of Lincoln and within the jurisdiction of this Court.

IT IS ORDERED, That Letters of Administration of the Estate of the said Rosa L. Wilhelm deceased, issue to the said petitioner John F. Wilhelm upon his taking the oath and filing a bond according to law, in the sum of Thirty-two Thousand (\$32,000) Dollars.

DEGREE OF SETTLEMENT OF ACCOUNTS  
AND FINAL DISTRIBUTION.

John F. Wilhelm, administrator of the estate of Rosa L. Wilhelm, deceased, having on the 3rd day of Feb., 1920, rendered and filed herein a full account and report of his administration of said estate, which account was for final settlement, and having with said account filed a petition for the final distribution of said estate;

And said account and petition this day coming on regularly to be heard by the Court, proof having been made to the satisfaction of the Court that said Administrator has given notice of the settlement of said account, and the hearing of said petition in the manner and for the time required by law;

And it appearing that said account is in all respects true and correct, and it is supported by proper vouchers; and that all vouchers thereof, together with the statements of the expenses and disbursements of said estate are now presented and filed; and it appearing that all claims and debts against said estate and all expenses and charges for the last illness of said deceased, and all funeral charges and all expenses and charges of the administration of said estate have been fully paid and discharged, and that said estate is now ready for distribution, more than one year having elapsed since the first publication of Notice to Creditors; It is, Therefore,

ORDERED, ADJUDGED AND DECREED, that the said final accounts of said Administrator be, and the same hereby are, settled, allowed and approved, and said Administrator be, and he is hereby discharged, and his bondsmen are released and discharged from their obligation; and that the residue of said estate hereinafter particularly described, and any other property not now known or described, which may belong to the said estate, or in which the said estate may have an interest, be, and the same is hereby distributed as follows:

All of said property is distributed to John F. Wilhelm, husband of said deceased being over the age of twenty-one years and residing at Daniel, Wyoming, and being the sole heir of said deceased, the following is a particular description of the residue of said estate referred to in this decree and over which distribution is now ordered as aforesaid; cash in the sum of \$15,781.46.
