NOTICE IS HEREBY GIVEN THAT C. H. CHEALEY, of Calpet, Sublette County, Wyoming, rendered services and performed labor for Akin Butte Oil Company, a corporation duly organized and existing under and by virtue of the laws of the State of Wyoming, hereinafter called "Operator", of which the following is a true, full and correct statement:

To services rendered and labor performed as driller in drilling and boring for oil, as follows: from the 18th day of December, 1927, to and including the 24th day of December, 1927, and the 28th, 29th, 30th and 31st days of December, 1927, and from the 1st day of January, 1928, to and including the 19th day of January, 1928, as driller at \$12.00 per day; total 30 days, or the sum of \$360.00, upon which there has been paid the sum of \$32.00 leaving a balance of \$328.00 due and owing this claimant; from the 20th day of January, 1928, to and including the 10th day of March, 1928, as caretaker and watchman at \$5.00 per day; total 50 days, or the sum of \$250.00; or the grant total of \$578.00.

That the said services were rendered and labor performed under a contract of employment whereby said operator employed said claimant to render and perform said labor and services as above stated and agreed to pay monthly therefor at the end of each calendar month for the services rendered and labor performed during said month, and that there is now due and owing from said operator to said claimant the sum of \$578.00 and interest thereon at seven per centum per annum from January, 19th, 1928, for said services rendered and labor performed.

That the premises and appurtenances on which said services were rendered and labor performed consist of: the Southeast Quarter of the Southwest quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$), and the South one-half of the Southeast Quarter (S $\frac{1}{2}$ SE $\frac{1}{4}$), and the Northeast quarter of the Southeast quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$) and the East one-half of the Northwest quarter of the Southeast Quarter (E $\frac{1}{2}$ NW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section Twenty-two (22), Township Twenty-seven (27) North, Range One Hundred Thirteen (113), West of the Sixth Principal Meridian, Sublette County, Wyoming, held and operated by said operators under a lease, together with one oil and gas well thereon being drilled at a point within the boundaries of said above described tract, and together with one oil well derrick at the location aforesaid of said well consisting of the following:

One 64 ft. wood derrick; 1515 feet of 6 $\frac{1}{2}$ inch casing;
 1000 feet of 8 $\frac{1}{2}$ inch casing; one 16 x 32 ft. frame
 box car style cook house; one 12 x 16 ft. frame bunk
 house; 275 feet of 12 inch casing; 17 joints of 10
 inch casing;

all the property of said operators and on said lands and used in the operation of drilling said well during the time stated in the account aforesaid.

WHEREFORE said claimant claims a lien upon the lands and premises aforesaid and the leasehold interest of said operator therein and the oil well and its appurtenances and the drilling rig, casing, buildings, equipment and appurtenances aforesaid and all thereof for the payment of his claim aforesaid and interest thereon as aforesaid.
