THIS AGREEMENT, made and entered into this 9th day of January, 1924, by and between The Denver-LaBarge Oil and Gas Company, a corporation, of the first part, and A. F. Stumpf, of Kemmerer, Wyoming, party of the second part;

WHEREAS, said party of the first part is the holder of and claims preference rights to the oil and minerals in all of Section Seventeen and the east half of Section Twenty, Township Twenty-seven North, Range One Hundred Thirteen West of the Sixty Principal Meridian, Wyoming, situate in Sublette County, Wyoming, by virtue of certain locations under the placer mining laws, and under the provisions of Sections 19 and 37 of the Act of Congress approved February 24, 1920 (Public No. 146); and, whereas, said second party has made application, at the Evanston, Wyoming land office, Serial No. 09561, under the provisions of said Act, for an Oil and Gas Prospecting Permit for the same land, together with and in addition thereto the following lands; all of Section Six and the east half of Section Seven, in said Township and Range, and has entered into a contract with third parties to test said lands by drilling the same with a suitable drilling machine, for the existence of oil and gas, thought to exist therein in commercial quantities; and,

WHEREAS, a conflict in the rights and titles of the said parties in the said above described lands is deemed to exist; and, whereas, it is deemed to be to the best interests of both of the said parties hereto that their respective interest shall be combined and harmonized, so that each party shall have and become seized of an undivided one-half interest in and to the whole and all of said above described lands, share and share alike, according to the nature of the tenure under which the same are or may hereafter be secured and/or held. NOW, Therefore, in consideration of the mutual promises and agreements between the said parties hereto, as hereinafter contained, This Indenture

WITNESSETH: That the said party of the first part does hereby sell, assign, transfer, convey and set over unto the said party of the second part, his heirs and assigns, an undivided one-half interest in and to the said above described lands, held by it, and claimed by it as aforesaid, together with the rents, royalties, issues and profits thereof, so that each of said parties shall and does own and hold an undivided one-half interest in and to the same.
