3. The amount of the capital stock of this company shall be \$10,000.00 to be divided into 100 non assessable shares of the par value of \$100.00 each.

4. That the terms of the existence of this corporation shall be fifty years from and after the date hereof.

5. The management of this corporation shall be vested in a Board of three directors, and said Directors shall have the power to make by-laws as they shall deem proper for the management and disposition of the stock and business affairs of said company, not inconsistent with the laws of this state, and prescribing the duties of officers artificers and servants that may be employed, for the appointment of all officers, and for carrying on all kinds of business within the object and purposes of said company; the names and residence of the Directors who have been selected for the first year are C. C. Feltner, Pinedale, Wyoming; Flora A. Feltner, Pinedale, Wyoming; and D. C. Carson, Pinedale, Wyoming.

6. The place where the principal place of business of this corporation shall be carried on is in the County of Sublette, in the State of Wyoming; the principal office of this corporation shall be at Pinedale, Sublette County, Wyoming.
