KNOW ALL MEN BY THESE PRESENTS:

That Floyd Norris of Big Piney, Sublette County, Wyoming for and in consideration of the sum of One (\$1.00) Dollar, and other valuable considerations, to him in hand paid by P. W. Jenkins of Big Piney, Sublette County, Wyoming, the receipt whereof is hereby confessed and acknowledged, has this day transferred, assigned and set-over and by these presents does transfer, assign and set-over unto the said P. W. Jenkins his administrators, executors and assigns, for the period of five years beginning with the 1st day of May, 1928 and ending with the 1st day of May, 1933, an undivided on-half interest in and to all royalties derived from oil or gas produced or discovered in commercial quantities on the following described land, to-wit:

The "outh one-half of the Southeast one quarter ( $\frac{1}{4}SE\frac{1}{4}$ ) of Section Twenty-nine (29); the Northeast one quarter ( $NE\frac{1}{4}$ ), and the East one-half of the Southeast one quarter ( $SE\frac{1}{4}SE\frac{1}{4}$ ) of Section thirty-two (32); the West one-half of the Northwest one quarter ( $W\frac{1}{4}NW\frac{1}{4}$ ) and the Northwest one quarter of the southwest one quarter ( $NW\frac{1}{4}SW\frac{1}{4}$ ) and the south one-half of the southwest one quarter ( $SW\frac{1}{4}SW\frac{1}{4}$ ) and the West one-half of the Southeast one quarter ( $W\frac{1}{4}SE\frac{1}{4}$ ) and the Southeast one quarter of the Southeast one quarter ( $SE\frac{1}{4}SE\frac{1}{4}$ ) of Section Thirty-three (33); the south one-half of the Southeast one quarter ( $SE\frac{1}{4}SE\frac{1}{4}$ ) of Section Thirty-four (34); the South one half of the Southwest one quarter ( $SW\frac{1}{4}SW\frac{1}{4}$ ) of Section thirty-five (35), all in Township Thirty (30) North, Range One Hundred Eleven (111) West of the Sixth Principal Meridian, Wyoming; Lots One (1), Two (2), Three (3), Four (4), Seven (7), Eight (8), and Nine (9) of Section Two (2); Lots One (1), Two (2), Three (3), Four (4), Seven (7), Eight (8), Nine (9), Fourteen (14), and the Northeast one quarter of the Southeast one quarter ( $NE\frac{1}{4}SE\frac{1}{4}$ ) of Section Three (3); and Lots One (1), Two (2), Three (3), Four (4); and the Southwest one quarter of the Northeast one quarter ( $SW\frac{1}{4}NE\frac{1}{4}$ ) and Lot Seven (7), and the Southwest one quarter of the Northwest one quarter ( $SW\frac{1}{4}NW\frac{1}{4}$ ), and the Northwest one quarter of the Southwest one quarter ( $NW\frac{1}{4}SW\frac{1}{4}$ ) of Section four (4); and Lot One (1) and the Southeast one quarter of the Northeast one quarter ( $SE\frac{1}{4}NE\frac{1}{4}$ ), and the East one half of the Southeast one quarter ( $SE\frac{1}{4}SE\frac{1}{4}$ ) of Section Five (5), all in Township Twenty-nine (29) North, Range one hundred eleven (111) West of the Sixth (6th) Principal Meridian, Wyoming, and containing Seventeen Hundred Seventy Nine and Fiftyfive hundredths acres, more or less;

Provided, always, that said interest herein assigned and conveyed shall inure and belong to the said P. W. Jenkins, his administrators, executors and assigns as long as oil and gas royalties, or either of them, are derived from said lands; and provided further that the said five year period hereinabove mentioned shall have no force or effect upon the interest herein conveyed and assigned, unless oil and gas, or either of them, are not discovered or produced in commercial quantities within the said period.
