The full use and possession for the purpose of pasturage only, of the following described land: Lots 1, 2, 3, 4, 5, and 7, SE $\frac{1}{4}$ NW $\frac{1}{4}$, E $\frac{1}{2}$ SW $\frac{1}{4}$, S $\frac{1}{2}$ NE $\frac{1}{4}$ and S $\frac{1}{4}$, Section 6, Tp. 35 North, Range 109 West, 6th Principal Meridian, reserving to the party of the first part, however, the right to pasture five head of stock.
