THIS INDENTURE, made and executed this third day of May, A. D. 1926, by and between OLIVER WILLSON and BLANCHE WILLSON, his wife, of Salt Lake City, Utah, hereinafter called the assignors, and C. D. SMITH of Salt Lake City, Utah, hereinafter called the assignee:

W I T N E S S E T H :

THAT WHEREAS, on the 24th day of February, A. D. 1926, Charles P. Budd, as lessor, and Guy B. Hockett, as lessee made and executed a certain oil and gas lease covering that certain tract of real estate in the County of Sublette, State of Wyoming, commonly known as the Corder Ranch, and particularly described as follows:

The northeast quarter of Section 9; The south half of the southeast quarter of Section 4; the north half of the northwest quarter, the southeast of the northwest quarter of Section 10; Township 29 North, Range 113 West of the 6th P.M., Wyoming, containing four hundred acres more or less;

which lease was duly recorded on March 25, 1926, in the records of Sublette County, Wyoming at page 380 in Book 1 of Miscellaneous, and by the terms whereof said lessor reserved as a rental or royalty seventeen and one-half per cent (17 $\frac{1}{2}$ %) of all oil and gas produced and saved from the leased premises (less transportation costs, government charges and taxes), the remaining eighty-two and one-half per cent (82 $\frac{1}{2}$ %) thereof becoming the property of said Guy B. Hockett, lessee; and

WHEREAS, on the 27th day of February, 1926, the said Guy B. Hockett and Frank Murphy made and executed a certain contract and assignment by the terms whereof said Guy B. Hockett, for certain considerations therein expressed, assigned to said Frank Murphy an undivided twenty-three and one-third per cent (23-1/3%) of the full one hundred per cent (100%) of all gas and oil produced and saved from said leased premises hereinabove described, together with a proportionate interest in said lease and all of the rights, benefits and privileges thereof, which contract and assignment was duly recorded on June 8, 1927, in the records of Sublette County, Wyoming, at page 88 of Book 2 of Miscellaneous; and
