THIS AGREEMENT, Made this 4th day of September, 1929, Between George F. Farrell and Marie Farrell, his wife, parties of the first part, and William Sherman, party of the second part, all of Big Piney, Sublette County, Wyoming.

WITNESSETH, That the said parties of the first part, for and in considerations of the covenants and agreements hereinafter mentioned, to be kept and performed by the said party of the second part, his heirs, executors, and administrators, have demised and leased to the said party of the second part, all those premises situate and lying in Big Piney, of the County of Sublette, and in the State of Wyoming, known and described as follows, to-witt

All of Lot numbered nine (9) in Block numbered three (3) in the Original Townsite of Big Piney, Wyoming, according to the Flat and Survey of record, together with the one-story, log and frame building situate thereon.

TO HAVE AND TO HOLD The above described premises, with the appurtenances, unto the said party of the second part, his executors, administrators and assigns, from November 4th, 1929, for and during and until November 4th, 1930. And the said party of the second part, in consideration of the leasing of the premises aforesaid by the said parties of the first part, to the said party of the second part, do covenant and agree with the said parties of the first part, their heirs, executors, administrators and assigns, to pay to the said parties of the first part, as rent for said premises, the sum of \$150 (One Hundred & Fifty Dollars) per month, payable as follows:
