IT IS THEREFORE ORDERED, ADJUDGED AND DECREED, That all that Real property, situated in the County of Sublette, State of Wyoming, and described as follows, to-witt:

The South half of the North half (S<sub>1</sub>N<sub>1</sub>) of Section twelve (12), in Township Thirty-three (33), Range One Hundred and eight (108) West of the Sixth Principal Meridian, all located in Sublette County, Wyoming, containing 160 acres, and appraised at \$6.25 per acre as shown by the Inventory and Appraisement filled in the above entitled cause.
