

And it appearing that the following named persons are the heirs at law of said deceased and represent all the persons entitled to an interest in said estate to participate in the distribution of the property of said estate, to-wit: George Thornton, a brother, residing at Republic, Washington; Peter Thornton, a brother, residing at Mt. Sterling, Illinois; Hugh Thornton, a brother, residing at Mt. Sterling, Illinois; Anna J. McDonnell, a sister, residing at Peoria, Illinois; Mary Thornton, residing at Wichita, Kas., 325 N. Wash. St.; Sarah Thornton, residing at 325 N. Wash. St., Wichita, Kas. (Children of deceased brother, Terrance.). Mary Nolen, residing at Timewell, Illinois; Clara Nolen Sullivan, residing at Prairie City, Ill. (Children of deceased sister, Mary Thornton Nolen).

And it appearing that the said Rody Thornton died intestate;

And it further appearing that there is in the hands of the said administrator cash in the sum of Thirteen Thousand Two Hundred One and 55/100 (\$13,201.55), and also the real and personal property hereinafter described, to be distributed as hereinafter provided;

And it further appearing that the said estate is now in the condition to be finally distributed unto the persons entitled thereto, and the administration thereof to be brought to a close, and all and singular the law and the premisses being by the Court seen, heard, understood and fully considered;

It is hereby ORDERED, ADJUDGED and DECREED;

1. That due and legal notice of the hearing of the said final accounts and petition for final distribution has been given;

2. That the said final account be and the same is hereby settled, allowed and approved as rendered;

And it is FURTHER ORDERED, ADJUDGED and DECREED;

That all the rest and residue of the property, both real and personal, constituting the estate of the said Rody Thornton, deceased, hereinafter particular described, and now remaining in the hands of the said John R. Arnold, Administrator, and any and all other property that may belong to said estate, or in which said estate may have any interest, be, and the same are hereby distributed as follows, to-wit:

1. To GEORGE THORNTON, one-sixth (1/6) of the money in the hands of said administrator, amounting to the sum of Twenty-two Hundred 25/100 Dollars (\$2200.25), and an undivided one-sixth (1/6) interest in the real and personal property hereinafter described;
2. To PETER THORNTON, one-sixth (1/6) of the money in the hands of said administrator, amounting to the sum of Twenty-two Hundred and 26/100 Dollars (\$2200.26) and an undivided one-sixth (1/6) interest in the real and personal property hereinafter described;
3. To HUGH THORNTON, one-sixth (1/6) of the money in the hands of said administrator, amounting to the sum of Twenty-two Hundred and 26/100 Dollars (\$2200.26) and an undivided one-sixth (1/6) interest in the real and personal property hereinafter described;
4. To ANNA J. McDONNELL, one-sixth (1/6) of the money in the hands of said administrator, amounting to the sum of Twenty-two Hundred and 26/100 Dollars (\$2200.26) and an undivided one-sixth (1/6) interest in the real and personal property hereinafter described;
5. To MARY THORNTON, one-twelfth (1/12) of the money in the hands of said administrator, amounting to the sum of Eleven Hundred and 13/100 Dollars (\$1100.13) and an undivided one-twelfth interest in the real and personal property hereinafter described;
6. To SARAH THORNTON, one-twelfth (1/12) of the money in the hands of said administrator, amounting to the sum of Eleven Hundred and 13/100 Dollars (\$1100.13), and an undivided one-twelfth interest in the real and personal property hereinafter described;
7. To MARY NOLEN, one-twelfth (1/12) of the money in the hands of said administrator, amounting to the sum of Eleven Hundred and 13/100 Dollars (\$1100.13) and an undivided one-twelfth (1/12) interest in the real and personal property hereinafter described;
8. To CLARA NOLEN SULLIVAN, one-twelfth (1/12) of the money in the hands of said administrator, amounting to the sum of Eleven Hundred and 13/100 Dollars (\$1100.13) and an undivided one-twelfth (1/12) interest in the real and personal property hereinafter described;

The following is a particular description of the said residue of said estate, referred to in this Decree, and of which distribution is ORDERED, ADJUDGED and DECREED as aforesaid, to-wit:

All of the ranch, tools, implements and machinery, harness, furniture and equipment now being and remaining upon the ranch and the real-estate hereinafter described;

All of the hay, feed and provisions now being and remaining on said ranches and real estate;
