WHEREAS, Burleigh Binning has presented to the board of Control of the State of Wyoming proof of the appropriation of water from Lake Creek, Tributary Willow Creek, Tributary West Fork New York River through the anl. Binning Ditch No. 3 under Permit No. 4566 anl. for irrigation of the lands herein described, lying and being in Sublette County, Wyoming.

NOW KNOW YE, That the State Board of Control, under the provisions of Chapters 65 and 68, Wyoming Compiled Statutes, 1920, has, by an order duly made and entered on the 14th day of November, A. D. 1930, in Order Record No. 7, Page 347, determined and established the priority and amount of such appropriation as follows:

Original Supply for following lands by Burleigh Binning  
18 acres in SW $\frac{1}{4}$ SE $\frac{1}{4}$ , Section 6, Twp. 34 N., Range 109 W.

The right to water hereby confirmed and established is limited to irrigation and the use is restricted to the place where acquired and to the purpose for which acquired; rights for irrigation not to exceed one cubic foot of water per second for each seventy acres of land for which the appropriation is herein determined and established.
