

Edith N. Jomen, widow of decedent, aged over 21 years; Margaret F. Jomen, daughter of decedent, aged about 6 years; Thomas K. Jomen, son of decedent, aged about 3 years, all residing at or near the Village of Boulder, County of Sublette, State of Wyoming;

and that said heirs and next of kin are still living and entitled to share in the distribution of said estate.

And the court further finds that there has been published a notice to creditors of said estate for the time and in the manner provided for by law, proof of which publication was filed with the Clerk of this court on June 26th, 1930; and that there has been an inventory and appraisal filed herein and that said estate was thereby appraised at the sum of twenty-five Thousand, Six Hundred Fifty-seven and 30/100 (\$25,657.30) Dollars.

WHEREFORE, IT IS CONSIDERED, ORDERED, ADJUDGED AND DECREED that all of the acts and proceedings of Edith N. Jomen, Administratrix as appearing on the records herein, and filed in the office of the Clerk of this court be and the same are hereby confirmed; and it is further ordered that she be and she is hereby ordered and authorized to pay the Administratrix's fees, the attorney's fees, publication fees and court costs, and the same are adjudged to be lawful claims and charges against said estate.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that all of the residue and remainder of said estate of Knute J. Jomen, deceased, heretofore particularly described and now remaining in the hands and under the control and possession of said administratrix, be and the same is hereby distributed and decreed in the following manner and to the following named persons to wit:

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the said Administratrix shall pay, deliver and transfer to said heirs and distributees, the foregoing real and personal property, decreed and distributed to them, and shall record a certified copy of this Decree of Distribution in the office of the County Clerk, and Ex-Officio Register of Deeds in and for said County of Sublette, State of Wyoming, as her transfer and conveyance of said real property to said heirs and distributees; and that upon filing due and proper vouchers and receipts for the distribution of said personal property, and upon the payment of the expenses of administration, court costs and publication fees, the said Administratrix shall be fully and finally discharged from her trust as administratrix of said estate.
