in the State of Wyoming, for and in consideration of the sum of Twenty-five Dollars (\$25.00)  
receipt whereof is hereby confessed and acknowledged, have granted to C. B. Googer, of the  
same place, the exclusive right, privilege and license to enter upon and to pursue, hunt and  
shoot game birds and animals and to take game fish from the waters on the following described  
premises towit:The West-half of the North-east half (W<sub>1</sub><sup>1</sup> NE<sub>1</sub><sup>1</sup>), and the  
North-east Quarter of the North-west Quarter (NE<sub>1</sub><sup>1</sup> NW<sub>1</sub><sup>1</sup>)  
of Section 4, Twp. 32, North Range 108 West of the 6th  
P. M.And it is understood by and between the parties that the license herein granted to the  
said C. B. Googer is conditioned and limited to the use of the said C. B. Googer and such per-  
sonal friends to whom he may desire to extend the privilege, provided they are accompanied,  
when on such premises for the purposes of hunting by the said C. B. Googer.And it is further understood and agreed that the privileges and license herein granted  
shall not be abused, nor shall the said C. B. Googer permit any damage to be done on the said  
premises, nor any of the laws of the State of Wyoming pertaining to game and fish be violated  
by the said party or his friends when on said premises for the purpose of fishing or hunting.
